



## COUNTY COUNCIL COMPOSITION PUBLIC NOTICE OF INTENT TO PASS A BY-LAW

TAKE NOTICE that the Council of the County of Frontenac intends to pass the following by-law at the Regular Session of the Council of the County of Frontenac on Wednesday, May 20, 2009 at 8:30 a.m. at the County Offices, 2069 Battersea Road, Glenburnie, ON:

A by-law to expand the number of members of the Council of the County of Frontenac from four members to seven members and change the method of selection of these members to include the four heads of council of each of the Townships of the County of Frontenac and three members elected from two County wards.

THIS NOTICE is given in accordance with Section 219(1) of the *Municipal Act, 2001, S.O. 2001, c.25* (the "Act"). Also in accordance with Section 219(1) of the Act, County Council will hold the following public meetings in order to receive public input regarding the proposed changes:

The wards proposed are:

- ? Northern Ward 1 to be comprised of the Township of North Frontenac and the Township of Central Frontenac, excluding the former Township of Hinchinbrooke currently part of the Township of Central Frontenac; and
- ? Southern Ward 2 to be comprised of the Townships of South Frontenac and Frontenac Islands and including the former Township of Hinchinbrooke currently part of the Township of Central Frontenac.
